

## AGREEMENT OF COLLABORATION BETWEEN THE UNIVERSITY OF CÓRDOBA (SPAIN) AND THE INTERNATIONAL COUNCIL OF NEAR INFRARED SPECTRSCOPY (ICNIRS)

In Cordoba, on 11 th May 2012

## **ASSEMBLED**

On one side, Mr. Justo P. Castaño Fuentes, Vice Chancellor for Science Policy and Campus of Excellence of the UNIVERSITY OF CÓRDOBA (SPAIN).

On the other side, the Excellent Mr. Pierre Dardenne, President of the ICNIRS

They coincide in the point that academic, scientific and cultural collaboration is interesting for both institutions, and they decide to ratify the present Agreement according to the following:

## **CLAUSES**

**FIRST.-** the signatory Institutions of the present Agreement resolve to establish a frame for the collaboration in the following matters:

- Training on the level of Master's degree and Doctorate (PhD).
- Projects on postgraduate courses and activities.
- Editions and publications about subjects of common interest.
- Interinstitutional consultancies.
- Documentation and information exchange.
- Formation of thematic networks.
- Projects of development for communities with process/ product experience in which the Institutions have had previous experience.

Encouraging mainly those activities whose objective is the study of all those aspects related to planning and execution of regional development policies.

**SECOND.-** both Universities will be able to collaborate in mutual interest academic areas.

**THIRD.**- the practical execution of this Agreement will always be carried out by means of concrete collaboration programs and projects established under its protection as Specific Agreements.

The Specific Agreements will hold the concrete scheduling of the academic activities, involved teachers, expected trip dates, and precise financial details.

**FORTH.-** both Institutions will co-operate in the search for external financing necessary for the adequate execution of the collaboration programs, before national and/or international co-operation bodies.

**FIFTH.-** the pursuit and control of the activities originated within the present Agreement will be carried out by means of a Board made up by a representative of each of the Universities.

**SIXTH.**- for legal and/ or judicial effects, the parties set the domicile of the headquarters of the respective Chancellor's office.

**SEVENTH.-** the present Agreement will be valid for FIVE years, automatically renewable, and it will be possible for any of the parties to denounce it, prior written notification to the other party six month beforehand.
