Grounds for exclusion:

- **1.** The applicant is not professionally dedicated to teaching and research activities in the Agrifood sector (Section 2.1.1 of the call).
- 2. The applicant requests to teach in a program different from a BA or MA degree (Section 1.1 of the call).
- 3. The applicant does not submit all the required documentation, or submits it (fully or partially) outside of the application submission period (Sections 4.1 and 4.3 of the call):
 - a) Official application form
 - b) Copy of applicant's official identification document
 - c) Invitation letter from the Host Institution
 - d) Work Program or summary of teaching activities to be developed during the stay
 - e) Summary of the most outstanding teaching and scientific activities in the last three years.
 - f) Proof of language proficiency
- 4. The applicant does not proof sufficient language proficiency*.

*The evaluation committee established a B2 level (according to the CEFR) as the minimum language proficiency of non-native English speakers.

The present resolution concludes the administrative action (pursuant to art.6.4 of the Organic Law 6/2001, of 21^{st} December regarding Universities, and art. 32 of the Statutes of the University of Cordoba, approved by Decree 280/04, of 7^{th} October). Against this resolution, an administrative appeal may be brought within one month before the Rector of the University of Cordoba, or it may be contested directly before the administrative court (Article 109 of Law 4/1999 amending Law 30/1992).

The condition of final accepted applicant requires the submission of the completed <u>acceptance</u> <u>document</u>, available on the website of the call, at the Central Registry (*Registro General*) of the corresponding ceiA₃ Host institution (see post addresses in Annex I) until <u>20 June 2014 at 14:00pm</u>. The final accepted applicant **must notify this submission by email** and a scanned copy of the signed acceptance document should accompany this email as an attachment in PDF format. Failure to meet this requirement may result in exclusion from the list of final accepted applicants.
